As the Project Controls Specialist, you will oversee daily financial and governance processes that support the project's Assets Function, with a strong focus on safety, Thiess systems, procurement, subcontractor management, asset management, equipment warranty, planning, and execution.

# KEY RESPONSIBILITIES

- Demonstrate unwavering safety leadership, ensuring compliance with all health, safety, and environmental regulations.
- Maintain complete listing of equipment onsite, ensure JDE Asset Master register is up to date, follow up on any deficiencies,
- Collaborate with the Maintenance team in their day-to-day planning and execution of work, reward from a cost control perspective.
- Ensure data tracking mechanisms are being populated properly in Infomine (Thiess internal system) and Wenco
- Manage and reconcile internal and external maintenance labor costs, including subcontractors.
- Review and approve maintenance requisitions, ensuring purchases are within budget and have accurate coding
- Provide detailed cost analysis related to fixed assets, monitor costs against budget, provide commentary to variances and review with Maintenance Superintendent
- Manage the projects procure-to-pay process, including entering requisitions, processing invoices, accounts payable workflow (APWF), and JDE housekeeping.
- Maintain professional communication with suppliers, subcontractors, and clients.
- Develop strong working relationships with internal and external stakeholders.
- Ensure the integrity of the JDE Asset Master and liaising with the Corporate Asset Admin team.
- Implement and maintain scalable and efficient systems.
