## 1.0 PURPOSE

To ensure the implementation of the Ontario Lottery Gaming (OLG) Revenue Training fund in a fair and equitable manner for the benefit of the Wahnapitae First Nation (WFN) minor aged membership.

This allocation is intended to enhance the lives of our membership and provide them with an opportunity to expand their horizons, develop new skills, and explore areas of interest that may not normally be accessible to them. It is hoped that this allocation of funds will enable our minor aged children to join and participate in local activities, which may include but are not limited to music lessons, various sports as well as other activities that meet the outlined criteria.

## 2.0 ELIGIBILITY:

Wahnapitae First Nation band members not in arrears with other OLGR funded programs and under the age of 18.

## 3.0 ELIGIBLE ACTIVITIES:

The following are some examples of eligible activities: minor hockey, baseball, and basketball registration costs. Also, kickboxing, karate, taekwondo, girl guides, brownies, cubs/scouts, dance, enrollment in modeling agencies, and other recreational or sports activities.

Examples of eligible expenses include registration fees, necessary clothing and equipment with proof of registration.

## 4.0 ALLOCATION

Annual allocations will be in accordance with the on-going plan for the OLG Revenues and accessing funds will be on a first-come first-served basis annually.

The Council will allocate \$35,000.00 for an annual budget.

Members may access the funds to a maximum of \$1,000.00 for each fiscal year.

Initial contact with the WFN receptionist is required to ensure that funds are available, and that the activity is eligible under this policy. Requests for funding for lessons or training from immediate family members will be dealt with on a case-to-case basis. The following criteria will be used to determine accessibility.

WFN members must complete/provide the application/agreement form and any relevant documentation such as proof of registration costs, equipment costs and information on the activity at least 20 days prior to the date required. To ensure the funds are well utilized, applicants may be asked to complete a questionnaire and or submit a certificate or other type of verification of activity enrollment/completion. Completed applications can be sent to administration for processing.

Any requests from individuals who have not enrolled/completed an activity that has been paid for by the OLG Revenues fund will be declined until the registration fees/costs have been repaid.

## 5.0 FUNDING

- Eligible Activity: any registration fee, participation cost, and equipment for a registered activity for youth 18 years and younger.
- Travel: travel will not be covered.
- Meals: meals will not be covered.
- Accommodations: accommodations will not be covered.
- Equipment/Supplies: equipment/supplies pertaining to registered sports and recreational activities.

## 6.0 ESSAY REQUIREMENT:
